



CS Training and Refresher courses at Blue Door Psychotherapy

The 12-hour supervision training course, and the 6-hour refresher course, at Blue Door Psychotherapy meets the requirements for the Arizona Board of Behavioral Health Examiners.

Our units are each 2 hours long. They are well suited to either combining for two 6-hour days such as what would take place at a conference or dividing into 6 smaller 2-hour units for persons who prefer more contact time to learn and practice the skills.

CS (Clinical Supervision) **Training** program participants will complete units 1 – 6. Units 1 – 3 are intended to most heavily focus on the acquisition of knowledge and guidance on where to find information, and how to implement specific requirements. The focus of Units 4 – 6 is on reminders of specific requirements, changes that may have recently occurred or that are expected in the near future, theoretical frameworks for quality supervision, and recent research and instruments that are available. Persons taking the **refresher** course will be guided to participate in Units 4 – 6.

Each of the Units is concluded with a brief quiz, intended to serve as a reminder of a few key points in the presentations.

The fees for the courses are as follows:

Supervisor training 12-hour program: \$250

Supervisor refresher 6-hour program (Units 4 – 6): \$150

Supervisor training program, single sessions only: \$60 per Unit.

At this time, all of the sessions are live online sessions. It is expected that recorded versions will be available by late summer.
